PRIOR ANNOUNCEMENT

on the publication of Public Call No. 01/2020 for Submission of Requests for the Use of Measure 1 "Investment in Fixed Assets of Agricultural Holdings" in the field of Agriculture and Rural Development Policy of the Instrument for Pre-Accession Assistance for Rural Development of the European Union (IPARD Program 2014-2020)

The Government of the Republic of North Macedonia and the Agency for Financial Support in Agriculture and Rural Development shall notify all interested legal entities and individuals that in the second half of January 2020 a Public Call for Submission of Applications for Measure 1 shall be published. " Investment in fixed assets of agricultural holdings "in the field of agriculture and rural development policies of the Instrument for Pre-Accession Assistance for Rural Development of the European Union (IPARD Program for the period) 2014-2020 year).

The purpose of the IPARD Program 2014-2020 is through appropriate measures to support agriculture and rural development to improve the competitiveness of agricultural production and agri-food sector, by aligning them with European Union standards and achieving sustainable environmental and socio-economic development. rural areas by encouraging economic activity and increasing employment opportunities.

Measure 1 financial assets "Investment in Fixed Assets of Agricultural Holdings" under the IPARD Program 2014-2020 in connection with the implementation of this Public Call of January 2020 are intended for the following subsectors:

- Plant production;
- Livestock production;
- Processing and direct marketing of own agricultural production of agricultural holding;
- Renewable energy production for own consumption.

The rules for using the IPARD Program 2014-2020 funds require that the potential beneficiaries contract with the Agency for Financial Support in Agriculture and Rural Development and realization of the approved investment in accordance with previously agreed conditions. On-the-spot control and oversight of the contract is performed by authorized persons from the Agency for Financial Support in Agriculture and Rural Development and relevant institutions of the Republic of Northern Macedonia for the management, implementation and control of IPARD and the European Union.

The manner and procedure for using the financial support from the IPARD Program 2014-2020 are prescribed in the Regulation on the manner and procedure for using financial support for rural development measures financed by the Instrument for Pre-Accession Assistance for Rural Development of the European Union.

The announcement will last at least 45 days from the day the Public Call is published in the daily newspapers.

NOTE: Required documentation for preparation and submission of applications, including Customer Guidelines 1 "Investments in Fixed Assets of Agricultural Holdings" from the IPARD Program 2014-2020 will be updated and published on the Agency's web site in the period until the Public Announcement call.
