On the basis of Annex A Clause bb paragraph 1 point b from the Law on ratification of the Framework Agreement for financial partnership signed by and between the Commission of the European Communities and the Republic of North Macedonia represented by the Government of the Republic of Macedonia stipulating the specific procedures for implementation of the EU financial assistance to the Republic of North Macedonia under the Instrument for Pre-Accession Assistance IPA 3 (Official Gazette of Republic of North Macedonia no.235/22) and on the basis of the IPARD Programme 2021-2027 and article 6 from the Decree on the manner and the procedure for allocation of financial assistance for rural development measures funded under the IPARD Programme 2021-2027 (Official Gazette of RM no. 88/23)

for submitting applications for allocation of funds under the IPARD Program 2021-2027

PART I

1. The Agency for Financial Support of the Agriculture and Rural Development (hereinafter: The Agency) as a relevant institution and contracting authority for implementation of the EU Instrument for Pre-Accession Assistance for Rural Development (IPARD) invites all interested natural and legal parties from the Republic of North Macedonia to submit the applications for allocation of funds from the IPARD Programme 2021-2027 for the following measures:

Measure 7. Farm Diversification and Business Development

- 2. The financial support for this Public Call is comprised of 75% funds provided by the European Union Instrument for Pre-Accession Assistance for Rural Development (IPARD) according to the IPARD Programme 2021-2027 and 25% funds from the Budget of the Republic of North Macedonia.
- **3.** The Financial resources per single application shall be awarded as a non-refundable financial support (grant) in the amount of:

3.1. 60% of the value of the total eligible expenditures for the investments under Measure - Farm Diversification and Business Development. The percentage shall be increased up to 70% for investments by young farmers and/or certified organic producers and for collective investments.

The percentage for co-financing can be increased by an additional 10% for investments related to waste management, renewable energy and circular economy investment type from the (efficient, re-use of waste materials).

The ceiling for cumulative/combined financial support **must not exceed 75%.**

4. The deadline for submitting applications is 20 December, 2024.

The total financial support under this call for Measure 7 "Farm Diversification and Business Development" is 14.000.000,00 euros or 862.890.000 denars.

The euro exchange rate for this Call is 61.635 denars.

5. Forms and instructions:

The required forms of the "Application for allocation of funds for Measure 7 "**Farm Diversification and Business Development**" as well as the "Guidelines for Beneficiaries of funds for Measure 7 **Farm Diversification and Business Development** which comprises all information on the criteria, eligibility requirements for the projects and the funding conditions as well as any other information necessary for preparing an Application for allocation of funds under the IPARD Program 2021-2027, the Guidelines for drafting the Business Plan/Technical Project Proposal, Guidelines for issuing the necessary documentation from the relevant institutions and the other useful information in electronic form can be downloaded from the Agency's web address: <u>www.ipardpa.gov.mk</u>.

6. Submitting the application:

The Applicant shall fill out and submit an Application for allocation of funds for the individual measure, Business Plan or Technical Proposal developed according to the Guidelines for drafting the Business Plan/Technical Project Proposal and supporting documentation as specified in this Public Call.

The completed application for allocation of funds for the relevant measure along with the Business Plan/Technical Project Proposal and the overall documentation shall be submitted in a sealed envelope. The front of the envelope, in the upper left corner, should have an indication "DO NOT OPEN", for Public Call IPARD Programme 2021-2027 number 02/2024 and indication of the measure for which the application is sent. The application can be sent via registered mail or in person to the Archive of the Agency.

Note: For the purpose of performing on-the-spot controls by the Agency, the applicant should have copies of the overall documentation submitted to the Agency.

PART II

FARM DIVERSIFICATION AND BUSINESS DEVELOPMENT

1. Priority sectors

- Investments in alternative agricultural production (not supported under measures 1 and 3) including:
 - cultivation of mushrooms and truffles;
 - horticulture (nurseries and cultivation of flowers and flower buds, decorative plants, trees);
 - melliferous trees (for honey production), trees for timber, short rotation coppice and other fast-growing tree species for bio energy purposes;
 - production of seed and seedling material;
 - rabbit breeding;
 - snail breeding;
 - breeding of birds for eggs and meat ducks, geese, turkey, capercaillie, ostriches and emus and guinea fowls;
 - raising of game animals;
 - bee-keeping;
 - cultivation of herbs, seeds, and other spices and aromatic and pharmaceutical crops;
 - plantations of trees for timber and bio-mass (fast growing

Processing of alternative agriculture products (not supported under measures 1 and 3)

- processing and marketing of mushrooms and truffles;
- slaughtering, processing and marketing of rabbit meat;
- processing and marketing of snails;
- slaughtering, processing and marketing of birds for meat ducks, geese, turkey, capercaillie, ostriches and emus and guinea fowls;
- marketing (selection, package, labelling etc.) of eggs from ducks, geese, turkey, capercaillie, ostriches and emus and guinea fowls
- slaughtering, processing and marketing of game animals;

- processing and marketing of honey and bee-keeping products;
- processing and marketing of herbs, seeds, and other spices and aromatic crops.

> Production of food products and beverages

Under this sector eligible investments are for production of food products and beverages for human consumption according to the Law on food safety, which are not eligible for support under measure 1 and measure 3 (water, drinks and beer)

> Support of crafts activities

All activities stipulated with the "Rulebook on amending the Rulebook on defining the activities that can be performed by craftsmen" Official Gazette of the Republic of Macedonia No. 44 of April 1, 2009.

> Support of services for the rural population only for the following sub-sectors

- residential nursing care services (homes for the elderly, convalescent homes, etc.);
- child day-care services;

> Support of services to agriculture, only for the following sub-sector

establishment and upgrading of veterinary services;

Eligible recipients in sector 7 "Support for services in the agriculture" are legal entities, cooperatives and associative legal entities with headquarters in rural municipalities according to the Annex 1 of this Programme.

> Support of rural tourism

- tourist accommodation indoor accommodation (rooms, apartments, Bed &Breakfast, selfcatering cottages)
 - Proposed by natural person, the achieved capacity should not be more than 10 rooms accommodating a maximum of 20 guests (not including extra beds for children);
 - Proposed by legal entity, the achieved capacity should not be more than 20 rooms accommodating maximum of 30 guests (not including extra beds for children),

Tourist accommodation - outdoor accommodation (camping sites, bungalows, trailer camps);

- Proposed by natural person, the achieved capacity should not be more than 10 accommodation units or accommodate 30 guests (not including extra beds for children);
- $\circ~$ Proposed by legal entity, the achieved capacity should not be more than 15 accommodation units or accommodate 30 guests (not including extra beds for children).

Catering service (cooking and serving food);

- Proposed by natural person, serving capacity must not exceed 50 guests;
- Proposed by legal entity, capacity for serving must not exceed 150 guests

> Combined services – accommodation and catering service;

- Proposed by natural person, the capacity should not be more than 10 rooms that can accommodate maximum of 20 people (not including extra beds for children) or 10 accommodation units that can accommodate 30 guests at the same time (not including extra beds for children) and to serve 50 guests;
- Proposed by legal entity, capacity not more than 20 rooms to accommodate maximum of 30 people (not including extra beds for children) or outdoor accommodation of maximum 15 accommodation units or to accommodate 30 guests at the same time (not including extra beds for children) and to serve a maximum of 150 guests.
- > Provision of tasting rooms/selling points for direct marketing of products;
- Rural museums (buildings and exhibition items expressing historical, natural, traditional, educational, agricultural etc. amenities of the rural area, as well as botanical and zoological gardens);
- > Provision of facilities for seminars and trainings, educational farms;
- > Provision of recreational activities for tourists.

Note: Investments in construction/reconstruction of rural tourism facilities should be built by adapting the style to the traditional architecture of the rural areas or be in accordance with the landscape setting of the environment, which can be shown through the Technical Drawings and Design by authorized architects, and elaborated in the Business Plan.

For the Beneficiaries - natural persons, the construction category stipulated in the Rule Book on Real Estate Survey ("Official Gazette of the Republic of Macedonia" no. 121/2013, 169/2013, 95/2015, 128/2015, 157/2016, 176/2016, 195/ 2016, 135/2017, 41/2018, 48/2019 and "Official Gazette of the Republic of North Macedonia" No. 183/2019) in accordance with the purpose does not constitute a restriction when submitting Application for allocation of funds, provided that the Beneficiary registers the economic activity after the implementation of the investment, and before submitting the claim for payment in accordance with the Law on performing catering activities in the local self-government unit.

2.Beneficaries

Natural persons who are registered as living in rural area and/or have registered economic activity in the rural area, such as:

- Natural person registered as craftsman in the Crafts Registry according to Law on crafts for the activities for which the investment is proposed,
- Natural person registered as catering (including provision of accommodation) in the Catering Registry
 according to Law on catering for the activities for which the investment is proposed,
- Natural person registered as sole proprietor in the Central Registry according to Company Law.
- Natural person registered in the Farm Register as representative of family agriculture holding, and

• Natural person registered as individual agriculture producer in the Register of Individual Agriculture Producers in MAFWE or in the Pension and Disability Fund.

Natural persons who are proposing new investments for entering into economic activities in rural areas (e.g. for self-employment) are eligible for support under this measure subject to fulfilling the specific requirements at the end of the investment, in particular if he/she is:

- has proven professional skills and competences through a completed secondary education or a minimum of 3 years of work experience in the field of agricultural production, processing or services related to agriculture (proved through proof of professional work experience or through proof as a beneficiary of national programs for support in the agriculture and rural development or other acceptable written evidence) or professional training or other professionally recognized certificate for separate economic non-agricultural activity (for priority sectors 2,3,4,5,6,7 and 8);
- undertakes that at the end of the investment (before submitting the final claim for payment) he/she
 will register the economic activity as a craftsman, caterer, sole trader or legal entity in the municipality
 where the rural area is located.

Legal entities which are registered in the Central registry in the range of micro and small enterprises according to the criteria specified in the Recommendation of the European Commission 2003/361/EC ("it can be downloaded from the website of the Agency, <u>www.ipardpa.gov.mk</u>), summarized in the following table:

Note: According to the methodology for calculating the size of an entity from the mentioned recommendation, into account are taken the partner and related entities of the Beneficiary. When determining the size of the entities, the data from the Central Securities Depository of the Republic of North Macedonia for shares in joint stock companies of the beneficiary and all registered owners of the beneficiary are also taken. When determining the size of the entity, into account are taken related entities outside the Republic of North Macedonia. Newly established companies will be evaluated based on expected size as proposed in the technical project proposal/business plan.

The necessary data on the basis of which can be determined the size of the legal entity is obtained from the document "**OVERVIEW OF DATA FROM THE ANNUAL ACCOUNT**" issued by the Central Registry of the Republic of North Macedonia.

In terms of Call 02/2024 for defining the size of beneficiaries, shall be used the data from the "OVERVIEW OF DATA FROM THE ANNUAL ACCOUNT FOR 2021, 2022 and 2023"

Cooperative which is registered in the Central registry.

Associative legal entities (for collective investments) controlled by agriculture producers and are recognized as such under the Law. The following types of associative legal entities can apply and can use the support under this measure

- Cooperative
- Producer groups and producer organizations recognized as such in accordance with the Law on Agriculture and Rural Development and registered in the Register of Producer Groups and/or the Register of Producer Organizations administered by MAFWE,

- Private company with primary activity in agriculture or processing of agricultural products founded by authorized representatives of a family agricultural holding registered in the Farm Register and
- Private company with primary activity in agriculture or agricultural processing founded by an association of agricultural producers

The minimum number of agricultural producers engaged under any of the above entities is 10.

3 Common Eligibility Criteria

- The investments must be implemented on the property owned by the applicant. In case the investment projects, is implemented on property which is not in ownership of the applicant, the applicant must present document proving the right of use of the property subject to the investment for period of minimum 7 years from the date of applying for support. The property list must include the lease contract, the duration of the lease and area subject to the lease.
- The Applicant shall provide certificate, document that proves the professional competences for minimum secondary school education or higher education or vocational education or vocational training by diploma/certificate. The applicants that fail to meet the above-mentioned skills and competences shall at the end of the investment provide training certificate issued by relevant vocational training institutions, educational and research institutions or public advisory services including the list of attended training modules with relevance to the investment.
- At least one responsible person of the individual agriculture producer, legal entity or cooperative must be permanently employed or engaged under contract with duration not shorter than 5 years from the date of submitting the application for financial support.
- Natural persons shall be permanently employed as sole proprietors, craftsmen or caterers at the end of the implementation of the investment. In case of new investments (newly established companies that have not submitted an annual account or newly established legal entity) this requirement shall be achieved prior the submission of final payment claims.
- The Beneficiaries represented by the legal entity whereby the public authority(ies) or the state has capital ownership of over 25%, are not eligible beneficiaries under this measure.
- The project is eligible for financing if the location where the investment will be implemented is located in a rural environment.
- Financial support can be granted to Beneficiaries whose investment projects enable financial/ economic sustainability. Economic and financial viability will be assessed based on a Business Plan or Technical Project Proposal. The Beneficiary should demonstrate the possibility of business viability during at least five years from the implementation of the investment.
- In case of proposed projects which total eligible expenditures exceed 80,000 euros in MKD denars, the economic and financial viability will be evaluated via Technical Project Plan comprising of the following financial indicators:
 - Modified internal rate of return which should be greater than 0,
 - Net present value >0, and
 - Investment return period < 10 years
- In case of proposed projects with total eligible costs less than 80,000 euros in MKD denars, the economic viability is demonstrated through Technical Project Proposal that will contain financial indicators in terms of generating income that will compensate the costs.

- The proposed investment must present low inefficiency risk from public funding, i.e., that the beneficiary has the opportunity to implement the investment without financial support from the Program. The investments/projects will be excluded from support through a special procedure that includes:

Targeting Beneficiaries by size: if the average net profit of the Beneficiary and all related subjects (over 50% ownership capital or management rights) in the last three years from publishing the public call is less than 75% of the total eligible costs of the investment, then it is estimated that the risk from inefficiency of public financing is estimated to be low). Also, the risk from public funding is considered high if the average number of employees in the last 3 years (calculated according to the 2003/361/EC entity size recommendation) is between 30 and 50.

Prioritizing economically unattractive types of investments (for environmental protection, climate change adaptation, etc.);

Prioritizing investments in territories with a lower index of regional development.

For the purpose of efficient allocation of financial resources, the Agency via relevantly established Methodology will undertake evaluation of the need for co-financing the beneficiaries through the Program.

This criterion is not applicable to investments with financial support that does not exceed EUR 100,000 in MKD denars.

4.Aid Intensity

- The minimum total eligible expenditures for the proposed investment (project) for this measure must not be lower than 10,000 euros in MKD denars not including value added tax (VAT), while the maximum financial support that can be granted to a single beneficiary according to this measure, for an individual project is 600,000 euros in MKD denars without VAT. In case, the projects exceeds the value, the Agency shall proportionally deduct all eligible costs to the maximum amount of 600.000 euros in Macedonian denars. In the event that the investments exceed the specified value, the Agency shall proportionally deduct all eligible costs to the maximum amount of 600.000 euros in MKD denars.
- The maximum financial support that can be granted to newly established legal entities (legal entity that has not submitted an annual tax report for the last fiscal year preceding the year of the public call) under this measure is 100,000 euros in MKD denars. In case, the projects exceed the value, the Agency shall proportionally deduct all eligible costs to the maximum amount of 100.000 euros in Macedonian denars.
- The maximum financial support that can be granted to a single beneficiary under this measure is 1,500,000 euros in MKD denars, not including the value added tax (VAT) for the entire period of the implementation of the Program.
- The total public expenditure (75% EU participation + 25% national participation) which is paid in the form of co-financing of the investment under this measure amounts to 60% of the total eligible expenditures of the investment.
- This percentage of co-financing can be increased up to 70% for investments proposed by young farmers and/or certified organic producers and for collective investments.
- > The percentage of co-financing can be increased by an additional 10% for investments related to waste management, renewable energy and circular economy type investments (efficient, further use of waste materials).

> The highest cumulative/combined level of support must not exceed 75%. The Beneficiaries may submit multiple projects under this measure during the implementation of the Program, provided that the maximum total financial support is not exceeded and that the final claim for payment for the previously implemented project has been submitted to the Agency for Financial Support in Agriculture and Rural Development.

5.List of required documents

Pursuant to the Law on amending and annexing the Law on Establishing the Agency for Financial Support of Agriculture and Rural Development (Official Gazette of RM. No.190/2019), the overall documentation listed below in this Public Call should be submitted at the moment of submitting the application for financial support, otherwise the application will be rejected.

The bellow-listed documents submitted as supporting to the application for financial support from the IPARD Program 2021-2027 should be original or notarized, unless otherwise specified in the document.

If the documentation is in another language, it should be accompanied by a translation into Macedonian certified by a certified translator. Documents issued on the basis of public records or an established system of records shall not be older than three months from the date of announcing the Call, with the exception of documents confirming the fulfillment of the paid tax and contributions which should not be older than one month from the date of announcement of the Public Call.

PART III ADMNIISTRATIVE PROCEDURE

The administrative procedure in the Agency from the receipt of the applications to signing the Contract for allocation of funds consists of:

- 1. **Completeness check** of the submitted documents against the required documents by types of investments:
- Whether the application has been completely filled out and whether the supporting documentation referred to in this Call has been submitted.

An incomplete application for financial support is the Application that does not contain the complete documentation at the time of its submission.

• Whether the documents enclosed to the application are original or a notarized copy (unless otherwise stated in the document itself).

2. **The eligibility check** of the application for allocation of funds shall be checked in order to determine:

- Whether the submitted documents prove compliance with the eligibility criteria and conditions of the proposed investment activities;
- Whether the proposed investment is economically and financially viable and sustainable, which is checked by analyzing the parameters contained in the attached business plan / technical proposal;
- Whether the proposed investment for which financial support is sought is not funded by other public sources of funding (Budget of the Republic of North Macedonia and international donors);
- Whether the prices of the proposed investment activities are within the range of market prices by analyzing the reference prices for the respective activities.

Assistance may be granted to the beneficiaries whose investment projects provide financial/economic sustainability. Economic and financial sustainability will be assessed on the basis of a Business Plan or a Technical Proposal. The Applicant with the Business Plan should present the possibility of continuity of operation minimum five years after the realization of the investment. The investment project will be assessed based on the following economic indicators:

- Modified internal rate of return >0,
- Net present value > 0, and
- Period of return on investment < 10 years.

In case of projects with total eligible expenditures that do not exceed 80 000 euro in MKD denars, the financial viability must be demonstrated via Technical Project Proposal that will include financial indicators in terms of generating sufficient income to meet the operating costs of the agriculture holding.

In order to establish the authenticity of the technical parameters, economic and financial data, the Agency shall have the right to request additional documents and information as a basis for making a decision.

The verification of the authenticity of the data contained in the Application for allocation of funds is performed by authorized persons of the Agency with on-the-spot control.

The rankings shall be made for all complete and eligible applications for allocation of funds in accordance with the attached ranking tables by individual measures.

Financial support will be granted for all complete and eligible applications for allocation of funds within the budget of available funds by measure on the basis of administrative and on-the-spot control.

Incomplete, ineligible applications as well as applications for allocation of funds that have a lower point than available disposable funds will be rejected with a Decision.

The Beneficiary, who has been approved for allocation of funds, shall sign Contract within 30 days from the date of receiving the Decision for allocation of funds from the IPARD Program.

Beneficiaries must not begin with implementation of the investment prior to the signing of a Contract for the allocation of funds with the Agency, with the exception of activities related to general costs (business plan development, technical proposal design, feasibility study, architects, project documentation).

According to the Agreement for Financial Support, the Beneficiary has the right to request an advance payment in the amount of up to 50% of the value of the approved financial support within a period of no longer than 60 days from the date of signing the Agreement for Financial Support. The request for an advance payment is a standard form that can be obtained by the Beneficiary at the Agency's premises and can be downloaded from the website of the Agency: <u>www.ipardpa.gov.mk</u>.

For the purpose of authorizing and payment of advance funds, the Beneficiary must provide bank guarantee in the amount of 110% of the amount of the advance payment in addition to the request for advance payment. The amount for co-financing of the investment will be deducted by the amount of the advance payment during the final payment of funds.

Upon completion of the investment, the Final Beneficiary is obliged to submit to the Agency a claim for payment. The claim for payment is an accompanying document to the Contract signed between the Beneficiary and the Agency. Together with the claim for payment, the Beneficiary must submit supporting documentation related to the incurred expenses (invoices, bank statement) and other documents specified in the claim for payment. The documents that will be submitted by the Beneficiary must be verified with signature and seal of the authority/company that issues them and with signature by the Beneficiary (and seal - when the Beneficiary is a legal entity).

The claim for payment is a standardized form that the Fina Beneficiaries receive when signing the Contract for financial support, for each individual measure. The Claim for payment will also be available at the Agency's premises and can be downloaded from the Agency's website.

The Claims for payment must be submitted within the deadline specified in the Contract for financial support. The Beneficiary is obliged to complete the Claim for payment manually or electronically and submit the invoices /pro-invoices to the Agency, specifying the measure and type of investment.

The review of the financial documentation is performed exclusively on the originals or notarized copies. In the event that original documents are submitted, the Agency is obliged to send them back to the final

beneficiary during the payment authorization procedure. They will be stamped with the Agency seal to avoid further double funding.

If the documents accompanying the Claim for payment are submitted after the deadline, the application will be rejected fully or partially and the contracted amount of financial support will not be paid or will be partially paid.

If there are any changes to the Claim for payment, i.e. if the Beneficiary has procured activities that are not subject to the contract and there was no request for signing an annex to the contract, the claim will not be paid, or will be partially paid depending on the effect that the change will have on the total investment, subject to the contract.

If the beneficiary fails to comply with the contract provisions relating to the deadline for implementation of the investment, it should be borne in mind that all activities incurred prior to the signing of the contract (except the General Costs) will not be part of the financial support. Furthermore, all activities which have been procured and paid after the deadline, i.e. after the deadline for implementing the investment or within the deadline for submitting the claim for payment will not be subject to financial support or they will be subject to penalties in compliance to the Law on establishing the Agency for Financial Support of the Agriculture and Rural Development and the Contract for Financial Support.

After the administrative check verifies that the claim for payment is complete and eligible, the project/investment will be checked on-the-spot by authorized agents of the Agency who aim to verify the implementation of the investment in full and in accordance with the contract. After on-the-spot control, the Agency's controllers will draw up a Report elaborating on the actual on-site situation. The Report should be signed by the controllers and the Beneficiary or the person authorized by the Beneficiary. In case of any comments/notes during the control, the beneficiary has the right to indicate it in the report.

After having performed the control, if the Agency identifies that the investment has been fully implemented and is in accordance with the contract, the payment authorization procedure shall continue. If there is indication of full incompliance with the investment implementation in accordance with the Contract, the Agency shall continue with the procedure for rejecting the claim for payment.

Once the Claim for payment is approved, the Agency issues a Decision for authorization of payment. If the Claim for payment is rejected, the Agency shall issue a Decision for rejection.

The Decision shall inform the final beneficiary of the authorized or rejected amount.
