

## Reimbursed Beneficiaries of funds from the IPARD Program under the eight Public Call (01/2013)



Following the successful realization of the investments, fifty four Beneficiaries who have signed Contracts with the Agency, for allocation of funds from the IPARD Program under the eight Public Call (01/2013), have obtained funds for rural development.
