



Reimbursed another seventeen Beneficiaries of funds from the IPARD Program under the eight Public Call (01/2013)



Following the successful realization of the investments, seventeen Beneficiaries who have signed Contracts with the Agency, for allocation of funds from the IPARD Program under the eight Public Call (01/2013), have obtained funds for rural development.

The Agency for Financial Support of Agriculture and Rural Development has paid 295,680 denars to the Beneficiary Sonja Bojkovska from Pelagonia region for Reconstruction of orchards. Out of the totally paid funds, 221,760 denars are funds from the EU Budget and 73,920 denars are funds from the National Budget.

The Beneficiary Metodija Popovski from Pelagonia region was reimbursed an amount of 710,032 denars, out of which 532,524 denars are from the EU budget and 177,508 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Zlatka Markovska Stavreska from Pelagonia region was reimbursed an amount of 592,717 denars, out of which 444,538 denars are from the EU budget and 148,179 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Nevzat Shakirovski from Pelagonia region was reimbursed an amount of 797,888 denars, out of which 598,416 denars are from the EU budget and 199,472 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Saso Trajcevski from Resen was reimbursed an amount of 676,500 denars, out of which 507,375 denars are from the EU budget and 169,125 denars are funds from the National Budget. The funds are intended for Modernisation of open field vegetable production.

The Beneficiary Simo Kolevski from Southwest region was reimbursed an amount of 429,440 denars, out of which 322,080 denars are from the EU budget and 107,360 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Vanco Dolev from Vardar region was reimbursed an amount of 252,266 denars, out of which 189,199 denars are from the EU budget and 63,067 denars are funds from the National Budget. The funds are intended for Reconstruction of vineyards.

The Beneficiary Aleksandra Nikolovska from Pelagonia region was reimbursed an amount of 165,245 denars, out of which 123,934 denars are from the EU budget and 41,311 denars are funds from the National Budget. The funds are intended for Modernisation of open field vegetable production.

The Beneficiary Ivan Samandov from Vardar region was reimbursed an amount of 692,120 denars, out of which 519,090 denars are from the EU budget and 173,030 denars are funds from the National Budget. The funds are intended for Construction/Reconstruction and modernisation of fixed greenhouses.

The Beneficiary Nikola Talevski from Pelagonia region was reimbursed an amount of 746.220 denars, out of which 559.665 denars are from the EU budget and 186.555 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Agrar-DHC DOO from Kadino village, Prilep was reimbursed an amount of 641,357 denars, out of which 481,017 denars are from the EU budget and 160,340 denars are funds from the National Budget. The funds are intended for Modernisation of open field vegetable production.

The Beneficiary Julijana Trajcevska from Pelagonia region was reimbursed an amount of 184,149 denars, out of which 138,111 denars are from the EU budget and 46,038 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Anica Cvetkovska from Pelagonia region was reimbursed an amount of 131,785 denars, out of which 98,839 denars are from the EU budget and 32,946 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Frutema DOOEL, 13 Prvomajska street, Marena village, Kavadarci, was reimbursed an amount of 691,702 denars, out of which 518,776 denars are from the EU budget and 172,926 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.
