

### Reimbursed another twelve Beneficiaries of funds from the IPARD Program under the eight Public Call (01/2013)



Following the successful realization of the investments, twelve Beneficiaries who have signed Contracts with the Agency, for allocation of funds from the IPARD Program under the eight Public Call (01/2013), have obtained funds for rural development.

The Agency for Financial Support of Agriculture and Rural Development has paid 976,593 denars to the Beneficiary Maak Invest from Kavadarci for Reconstruction of orchards. Out of the totally paid funds, 732,444 denars are funds from the EU Budget and 244,109 denars are funds from the National Budget.

The Beneficiary Biljana Kotevska from Resen was reimbursed an amount of 880,000 denars, out of which 660,000 denars are from the EU budget and 220,000 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Goce Nonkovski from Resen was reimbursed an amount of 429,440 denars, out of which 322,080 denars are from the EU budget and 107,360 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Robert Rujanoski from Krivogastani was reimbursed an amount of 692,021 denars, out of which 519,016 denars are from the EU budget and 173,005 denars are funds from the National Budget. The funds are intended for Modernisation of open field vegetable production.

The Beneficiary Pance Angelovski from Resen was reimbursed an amount of 149,121 denars, out of which 111,841 denars are from the EU budget and 37,280 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Aco Malcev from Gradsko was reimbursed an amount of 520,079 denars, out of which 390,059 denars are from the EU budget and 130,020 denars are funds from the National Budget. The funds are intended for Reconstruction of vineyards.

The Beneficiary Cvetko Cakreski from Kavadarci was reimbursed an amount of 467,107 denars, out of which 350,330 denars are from the EU budget and 116,777 denars are funds from the National Budget. The funds are intended for Reconstruction of vineyards.

The Beneficiary Gjorgji Kostov from Sveti Nikole was reimbursed an amount of 455,253 denars, out of which 341,440 denars are from the EU budget and 113,813 denars are funds from the National Budget. The funds are intended for Reconstruction of vineyards.

The Beneficiary Marina Spasovska from Veles was reimbursed an amount of 109,821 denars, out of which 82,366 denars are from the EU budget and 27,455 denars are funds from the National Budget. The funds are intended for Reconstruction of vineyards.

The Beneficiary Salih Koca from Prilep was reimbursed an amount of 683,467 denars, out of which 512,600 denars are from the EU budget and 170,867 denars are funds from the National Budget. The funds are intended for Modernisation of open field vegetable production.

The Beneficiary Tasko Bosilkovski from Resen was reimbursed an amount of 578,561 denars, out of which 433,921 denars are from the EU budget and 144,640 denars are funds from the National Budget. The funds are intended for Reconstruction of orchards.

The Beneficiary Vojo Angelovik from Veles was reimbursed an amount of 515,429 denars, out of which 386,571 denars are from the EU budget and 128,858 denars are funds from the National Budget. The funds are intended for Modernisation of open field vegetable production.
