

Reimbursed payment of funds from the IPARD Program under the eight Public Call (01/2013)



Following the successful realization of the investments, eleven Beneficiaries who have signed Contracts with the Agency, for allocation of funds from the IPARD Program under the eight Public Call (01/2013), have obtained funds for rural development.

The Agency for Financial Support of Agriculture and Rural Development has paid 705,493 denars to the Beneficiary IF Dobra Zemja from Pelagonia region for Modernisation of open field vegetable production. Out of the totally paid funds, 529,119 denars are funds from the EU Budget and 176,374 denars are funds from the National Budget.

The Beneficiary Shpetime Sadiku from Pelagonia region was reimbursed an amount of 790,153 denars, out of which 592,614 denars are from the EU budget and 197,539 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Aco Simonovski from Pelagonia region was reimbursed an amount of 499,840 denars, out of which 374,880 denars are from the EU budget and 124,960 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Sema Shemshedinovska from Pelagonia region was reimbursed an amount of 297,387 denars, out of which 223,040 denars are from the EU budget and 74,347 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Marika Ristova from Southeast region was reimbursed an amount of 251,857 denars, out of which 188,892 denars are from the EU budget and 62,965 denars are funds from the National Budget. The funds are for Modernisation of open field vegetable production.

The Beneficiary Ilija Najdovski from Pelagonia region was reimbursed an amount of 159,197 denars, out of which 119,397 denars are from the EU budget and 39,800 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Ilija Butevski from Pelagonia region was reimbursed an amount of 149,488 denars, out of which 112,116 denars are from the EU budget and 37,372 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Blagojce Nasteovski from Pelagonia region was reimbursed an amount of 600,343 denars, out of which 450,257 denars are from the EU budget and 150,086 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Toni Stefanoski from Pelagonia region was reimbursed an amount of 592,973 denars, out of which 444,730 denars are from the EU budget and 148,243 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Zlatko Petrevski from Pelagonia region was reimbursed an amount of 699,343 denars, out of which 524,507 denars are from the EU budget and 174,836 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary Fari Sherifi from Pelagonia region was reimbursed an amount of 286,414 denars, out of which 214,810 denars are from the EU budget and 71,604 denars are funds from the National Budget. The funds are for Reconstruction of orchards.
