

The Agency continues with payment of funds from the IPARD Program under the ninth Public Call (01/2014)



Following the successful realization of the investments, sixteen Beneficiaries who have signed Contracts with the Agency, for allocation of funds from the IPARD Program under the ninth Public Call (01/2014), have obtained funds for rural development.

The Agency for Financial Support of Agriculture and Rural Development has paid 244.640 denars to the Beneficiary Hristo Uzunoski from Pelagonia region for Reconstruction of orchards. Out of the totally paid funds, 183.480 denars are funds from the EU Budget and 61.160 denars are funds from the National Budget.

The Beneficiary DPKTZP Vrv Zlaten List-Agrohemikal DOOEL, ul.Kiro Krstev br.55, Negotino, was reimbursed an amount of 423.667 denars, out of which 317.750 denars are from the EU budget and 105.917 denars are funds from the National Budget. The funds are for Reconstruction of orchards.

The Beneficiary DZPPU Adzi Promet DOOEL, from s.Belo Pole, Dolneni was reimbursed an amount of 802.429 denars, out of which 601.821 denars are from the EU budget and 200.608 denars are funds from the National Budget. The funds are for Modernisation of open-field vegetable production.
