

The Agency continues with payment of funds from the IPARD Program under the ninth Public Call (01/2014)



Following the successful realization of the investments, seventy Beneficiaries who have signed Contracts with the Agency, for allocation of funds from the IPARD Program under the ninth Public Call (01/2014), have obtained funds for rural development.

The Agency for Financial Support of Agriculture and Rural Development has paid 117.672 denars to the Beneficiary Silva Petrova from Vardar region for Reconstruction of vineyards. Out of the totally paid funds, 88.254 denars are funds from the EU Budget and 29.418 denars are funds from the National Budget.
