

**The Agency has realized payment of funds from the IPARD Program
under the ninth Public Call (01/2014)**



Following the successful realization of the investments, twenty two Beneficiaries who have signed Contracts with the Agency, for allocation of funds from the IPARD Program under the ninth Public Call (01/2014), have obtained funds for rural development.

The Agency for Financial Support of Agriculture and Rural Development has paid 277.493 denars to the Beneficiary Marjan Pavlov from Vardar region for Reconstruction of vineyards. Out of the totally paid funds, 208.120 denars are funds from the EU Budget and 69.373 denars are funds from the National Budget.

The Beneficiary Jovanche Mitreski from Pelagonia region was reimbursed an amount of 737.707 denars, out of which 553.280 denars are from the EU budget and 184.427 denars are funds from the National Budget. The funds are for Modernisation of open field vegetable production.

The Beneficiary Gorgi Gerasovski from Pelagonia region was reimbursed an amount of 151.114 denars, out of which 113.335 denars are from the EU budget and 37.779 denars are funds from the National Budget. The funds are for Reconstruction of orchards.
